CONDITIONS OF PARTICIPATION

1. The competition is available to all photographers.
2. Each author may send up to 6 works by e-mail.
- 2a. You can send a cycle of 3 or 5 photos - clearly marked CYCL – it will be counted as one work.
3. Photos must meet the following requirements:
 - **recorded as JPEG or TIFF,**
 - **300dpi,**
 - **longer side 42cm.**
4. Photos accepted for the exhibition will be printed in 32x45cm format in very good quality (Xerox Thermo) by the organizers.
5. Each sent photo file should be described: the name of the author and the place of taking the picture.
6. Participant, by sending photographs, confirms at the same time that he is the author.
7. Awarded photos will become the property of the organizers (only non-commercial use)
8. **Photos should be sent by e-mail to the address: konkursojczysta@gmail.com**
9. The submission of works means acceptance of the terms of the regulations.

Entry fee is mandatory for all participants and is: 30 PLN
